<u>Karma</u>

- The phenomenon of karma is pertinent to the 'unresolved issues' within a lifetime of experience that get trapped within the emotional body. If these emotional problems are not dealt within a lifetime efficiently, expediently, expressively, and in a prompt manner, they can become progressively more difficult to clear. As a result, cleansing of the emotional body cannot occur within the related course of incarnation.
- Upon insistence within the emotional body they can damage the RNA/DNA system through imprint of 'memory' insertion, which will get transmitted from one life to another.
- When the physical body perishes both the emotional and mental bodies remain intact and stay with the soul. The mental body transfers its knowledge and experiences attained during the incarnated lifetime as wisdom to the soul, while the emotional body leaves its unresolved emotional issues as karma, stamped or embedded within the soul permanently until it can be resolved during the next round(s) of reincarnation. Again, the problem becomes further complicated during proceeding incarnations due to the complexities associated with amnesia and lack of remembering the issues at hand to readily surface and clear from the emotional body.
- It has been suggested that karma imprinted on DNA gets transferred from the parents during procreation at the moment of inception of a new life. Therefore, there is the added complication of resolution of such inherited karma and its propagation to the new emotional and physical body of the offspring.
- The purpose of the soul is to make known the unknown; to expand in its awareness of Self-potential and ultimately experience as many different things

as possible so that a greater understanding or wisdom is attained about the nature of reality or "life" through direct experience.

- Moving through the full potential of experiences on Earth is simply not possible within only the 50 - 100 years or so of one life-time. Therefore, we must re-incarnate into a new body to continue our journey into higher understanding. It would require a huge amount of writing space to specify the evidence of this journey the soul goes through however, we are not interested in "convincing" anyone of this truth and respect contradictory beliefs regarding this so if interested we encourage you to research this yourself. This information is really for people who are already aware of this and are thereby empowered to act on this knowledge. Once the 4th DNA strand is active we are able to consciously separate from the physical body in the astral body and hereby become aware that "We" (our soul) continues beyond physicality ("transcendence") through direct experience. Until such a time however, we only have our intuition and rational logic to go on. This "separation" of the soul from the physical body is a natural occurrence at death although this can also occur during our life as specified above. When we become aware of this through personal experience, the fear of "Death" dissolves into higher understanding which facilitates a change in the way we conduct our lives into more meaningful experiences as the question arises, "Why am I here?"
- Following the completion of the physical body ("death") we move to a place (that many have called "The Plane of Bliss" or "Heaven") which corresponds to the frequency of the astral and light bodies. This corresponding environment (for most of us) is called the Second Harmonic Universe. This is simply a field of energy (similar to the 3-dimensional reality we exist in) which exists in a higher vibration and it is lighter. Because the particles in this (2nd harmonic) environment are more spaced out - less dense - It looks like the things in this reality have a light shining from within them; it is extraordinarily beautiful to see and interact with. However, we have had many, many experiences in this density as it represents an older level of creation. The newest level of creation is the density of physical matter that we currently exist in. That is why we are here; to explore the new environment. "New" is really a relative term as this

density has existed for billions of years, but in the infinite continuum of universal expansion; it is new.

- So there is a process by which we enter this density or the First Harmonic Universe:
- As a male and female make love and achieve orgasm together, the intensity of this experience brings their focus powerfully into the NOW moment as their energy fields merge together. In the power of this state of connection (corresponding to the penetration of the sperm and ovum) an inter-dimensional portal opens up between the 1st and 2nd Harmonic Universe allowing passage through of a soul waiting to return to Earth for continued experience in density. As this occurs and the egg (female genetic imprint) is connected with the sperm (male genetic imprint) to provide the physical body, the soul imprints it with its own personal configurations. This is why children in the same family with the same genetic parents have different personalities, abilities, strengths and weaknesses; it is because the soul carries these patterns based on the experiences of past lives and therefore needs to continue from where it left off.
- The seemingly unfortunate thing about this process is that because our emotions, feelings and experiences are imprinted into our DNA and genetic memory, the emotional "Issues", (limitations and distortions) that our parents were carrying at the time of conception are imprinted onto our body - the body being the product of both parent's genetic contributions. This is where the concept; "The 'sins' of the parents are passed onto the children"; as most of us still have emotional issues, frustrations and restrictions that we have not mastered before bringing a child into the world. As a result of this the child "inherits" emotional tendencies and behaviors which can inhibit and impair life experiences and people comment: "You've turned into your father/mother".
- This is in part, what the concept of "Karma" refers to. In addition to this imprint, the continued action of our choices throughout life results in further imprinting of our genetic code which (as described previously in the "What is an Auric Calibration?" email), continues to perpetuate our energetic state and

thereby corresponding energy field vibration and the resulting experiences that are magnetically attracted to us through this. It is not that anyone has done anything "wrong" and that we must "pay for our sins" like some religions suggest, rather everyone is just learning and our behavior produces a result. To understand that "result" it must return to us in experiential form and thereby learning can take place. This is actually Newton's third law of physics: "For every action there is an equal and opposite reaction". This refers to the effect our conscious/unconscious choices have on the energies of the environment. To learn and come to wisdom we are energetically connected to our "effect" so that it continues to come back to us ("What goes around comes around" etc.) and thereby, we can understand the meaning of it all.

- At this time in Earth's history however, there are many souls whom have incarnated to assist in the inter-dimensional shift the Earth is going through and are now carrying the undeserved genetic imprints of their parents which is now significantly impairing their ability to wake up to why they are here. Because of this we have been given a great dispensation whereby we can activate and clear these imprints from fetal integration so that the corresponding energetic burden is lifted and we can get on with our lives from a higher place of freedom. These imprints can sometimes be identified by what we "Can't stand" or don't like about our parents. There can be a subconscious awareness, frustration or resentment that we are carrying what is not ours.
- We can clear this imprint through what is called a Karmic Clearing Session. During this quantum healing session we target the highest priority karmic imprints from the male and female genetic lineages, as well as any archetypal imprints that we are guided to work on. As these patterns release on a quantum level the corresponding synaptic connections unplug from their ingrained frequency allowing a new pattern of higher configuration to set into the brain. This is experienced as a great freedom from the past and resulting uplifting energetic state as golden soul fragments that have been trapped in time since even before this life time are returned to your energy field as you integrate into a greater level of wholeness, empowerment and sovereignty.
